ADOPT A PASTOR/CHURCH TERMS AND CONDITION

1. This arm of the ministry seeks to alleviate the financial challenges associated with ministry in rural communities. Both benefactors and recipients shall only operate according to this vision.
2. No other relationship should exist between patrons and leaders facilitated by TLGHC without the knowledge of TLGHC.
3. The patron agrees to give unconditionally and the recipient agrees to receive gratefully with a monthly appreciation note (by text/email) to the patron.
4. TLGHC operates on an as-it-is basis. Ministers and ministries will be connected to benefactors only when they are available.
5. The patron reserves the right to give the estimated \$20+/- GHC 100+, under-give or over-give, depending on the provision of God to the patron.
6. No funds once sent to the minister/ministry may be refunded.
7. TLGHC is to be in no way involved with how much, and when money is sent to ministers/ministries. TLGHC would only look for needs on the ground and connect donors/patrons to the needs of these churches and ministers.
8. A donor reserves the right to withdraw from the program at any time that suits his/her convenience. Or change recipient of his/her freewill donations.
9. Where there are no funds from a benefactor/patrons, recipients can/shall not demand a change of donor.
10. A donor/patron reserves the right to donate monthly, quarterly or bi-annually.

11. No recipient/minister has a right to demand anything from any donor other than the freewill \$20+/ GHC 100+ giving of the donor. Donors also have family and businesses to attend to.
12. Funds from benefactors/patrons are for only those directly involved with Christian ministry in rural communities certified as "villages" by the TLGHC.
13. Recipients must be the head of the church/ministry or recommended by the head.
14. The church/ministry must be situated in a "village."
15. Donations are meant to supplement the work of the leaders and churches. Leaders are therefore encouraged to look for ways the church can generate revenue for fuller functions of the church/ministry.
16. No church/leader may be connected to more than one patron.
17. A benefactor/patron reserves the right to donate to more than one church/ministry/leader
18. Once TLGHC becomes aware of any improved financial situation of any leader/ministry, TLGHC reserves the right to cancel the said ministry/minister from the program.
19. Where a patron wants to keep his/her identity hidden and not give directly to a ministry/minister, TLGHC becomes the center for the distribution of the funds.
20. A donor can request receipts of donations ONLY after showing proofs of donations to the minister/ministry. Receipts are made available at the end of every year.
21. The funding should be used solely for the work of the ministry.
22. The Pastor cannot bother the donor for any other thing, including the free will monthly donations.
23. No minister/ministry can nor should apply for another minister/ministry
24. Once a minister quits ministry or moves to a city, he or she disqualifies himself/herself from the program.
25. The tlghc.org reserves the right to suspend the opportunity rendered any pastor/ministry at any time without prior notification.

- 26. The patron has the right to change the recipient but no recipient had the right to change a donor.
- 27. The TLGHC reserves the right to put the informations of recipients of the program from their application forms on their websites.
- 28. TLGHC reserves the right to do a background check on any ministry/minister and also audit the financial situation of any recipient of the program at any given time of the year.
- 29. The minister/ministry is encouraged to pray for his/her benefactor so God can continually bless him/her for the cycle of giving to continue and be done cheerfully.
